The Allen Victory Committee is a joint fundraising committee on behalf of Friends of George Allen ("Campaign") and the Republican Party of Virginia ("RPV"). Joint fundraising proceeds shall be allocated according to the following formula: (i) The first \$2,100 of any contribution by an individual or non-multicandidate federal PAC, or the first \$5,000 of any contribution by a multicandidate federal PAC, shall be allocated to the Campaign's general election account, and (ii) The remaining \$10,000 of any contribution by an individual or non-multicandidate federal PAC, or the remaining \$5,000 of any contribution from a multicandidate federal PAC, shall be allocated to the RPV federal account. Notwithstanding this allocation formula, a contributor may designate his or her contribution for a particular participant or group of participants. In addition, the allocation formula may change if a contributor makes a contribution which would exceed the amount that contributor may give to a particular participant. The maximum amount an individual may contribute to The Allen Victory Committee for calendar year 2006 is \$12,100. Individuals should review their personal contribution histories to determine how this contribution may affect their biennial contribution limit for the 2005/2006 election cycle. The maximum amount a multicandidate PAC may contribute is \$10,000, non-multicandidate PACs may contribute \$12,100. Contributions by corporations, foreign nationals, and federal government contractors are prohibited.
